Old Business

Follow up on foliage removal - the HOA doesn't own the outside rim of the property. It is owned by the city. This portion of the property is being maintained by the landscaping company, they have sprayed weed killer and will spray again.

Drainage issue:

Huntsville connect work was done by the city trying to minimize erosion by removing large trees. The city will not do any more. However the city needs to take care of this issue as it is their property. Claudia will reach out in an attempt to get a meeting with the city landscaping committee.

New business

Equipment for pool maintenance:

Claudia will continue to be reimbursed for property expenses after approval. No need for a petty cash account. She has approval to purchase a leaf blower. Sandra proposed a motion for \$500 to purchase the blower. Amanda seconded.

Storm damage - pool fence replacement (gazebo to gazebo) estimate of \$5300. Motion to approve by Sandra, Amanda seconded. Stephen will inquire with insurance company to find if it's worth filing. Removal of tree left behind 6707 - he should reach out to trash collection to get the rest removed. Stephen will set up OneDrive for storage of documents.
